AFFIDAVIT OF EXPERT WITNESS DR. AMBER FLETCHER

I, DR. AMBER FLETCHER, of the City of REGINA, SASKATCHEWAN, MAKE OATH AND SAY (or AFFIRM):

- 1. I hereby provide this opinion to the Court in my capacity as an academic and expert in several areas of social science, including gender studies and the social dimensions of climate change impacts.
- 2. I provide this opinion evidence contained herein in an objective and non-partisan manner. My opinion evidence provided herein is related only to matters within my areas of expertise. I am aware of my duties as an expert witness to assist the Court as prescribed in *The Queen's Bench Rules* at rule 5-37 and I have made this submission in conformity with those duties.
- 3. I am a social scientist and Associate Professor of Sociology and Social Studies at the University of Regina. I hold advanced degrees in the subject areas of sociology, gender studies, and public policy. I am an internationally recognized expert on the topic of gender

and climate change impacts. My current research examines how social inequity—particularly inequity on the basis of gender, socioeconomic status, rurality, and Indigeneity—affects people's experiences of climate hazards like flooding, drought, and wildfire. I also conduct research on women in agriculture, rural communities, gender in public safety occupations, philosophy of science, and social research methodology. Attached to this affidavit as **Exhibit** "A" is my Curriculum Vitae, which further describes my qualifications in greater detail.

- 4. Since 2012, I have published 60 peer-reviewed articles and book chapters, as well as two books, on the aforementioned topics. I am a contributing author to the 2019

 Intergovernmental Panel on Climate Change (IPCC) Special Report on Climate Change and Land, a key output of the IPCC's Sixth Assessment cycle. The IPCC is the United Nations' official entity responsible for assessing climate change research and is recognized as a global authority on climate change. I am also a contributing author to the 2022 Canada in a Changing Climate report² published by the Government of Canada (Natural Resources Canada), which is part of Canada's national climate change assessment process. I have provided 98 invited presentations in Canada and internationally, including presentations about the social impacts of climate change to audiences in Portugal, Spain, Sweden, Turkey, and the USA.
- 5. My research projects are funded primarily by competitive public grants, including the Social Sciences and Humanities Research Council (SSHRC), the Canadian Institutes of Health Research (CIHR), and the non-profit national research organization, Mitacs.
- 6. The Sixth Assessment Reports from the Intergovernmental Panel on Climate Change (the "IPCC") were released in August 2021 (Working Group One *Climate Change 2021: The Physical Science Basis*), February 2022 (Working Group Two *Climate Change 2022:*

Impacts, Adaptation and Vulnerability), and April 2022 (Working Group Three – Climate Change 2022: Mitigation of Climate Change). These reports clearly articulate the urgent need for immediate action and greater ambition to decarbonize at all levels of government. The findings of the Sixth Assessment Reports of the IPCC are much clearer and unequivocal regarding climate change risks than the findings of the Fifth Assessment Reports dating back to 2013/2014. The Sixth Assessment of the IPCC (2021³, 2022⁴), states unequivocally that human activities have contributed to warming of the atmosphere, ocean, and land, with an estimated 1.07 degrees likely attributable to human influence. The IPCC (2021) states that the rate of human-induced climate warming is unprecedented in the past 2000 years.

- 7. According to the IPCC (2021), greenhouse gas (GHG) emissions are the primary driver of human-induced (i.e., anthropogenic) climate warming since the reference period of 1850-1900. They also state that carbon dioxide (CO₂) emissions are the largest greenhouse gas contributor to climate warming. The 2021 IPCC report indicates that 2019 atmospheric concentrations of CO₂ were the highest in 2 million years.
- 8. According to the Government of Canada (2022⁵, ⁶), the oil and gas sector was the largest source of GHG emissions in 2020 and was the primary driver of increased GHG emissions between 1990 and 2020.

- 9. Scientific evidence suggests that anthropogenic climate change has contributed to increased frequency and intensity of heat waves, heavy precipitation, and drought, including agricultural drought (IPCC, 2021). Continued warming is expected to increase the frequency and intensity of these hazards in the future (IPCC, 2021).
- 10. A recent synthesis report completed as part of Canada's national climate assessment (Canada in a Changing Climate, 2022⁷) stated that, "Extreme weather events of amplified severity will likely be the most challenging consequence of climate change in the Prairie Provinces. The impacts of flooding, drought and wildfire in recent years are unprecedented, and climate models suggest an increased risk of these events in the future." The report identifies high risk of drought and convective summer storms, with the risk level rising to "extreme" with increased warming.
- 11. Climate change does not affect all people equally. The IPCC (2022) asserts with high confidence that gender and other forms of social inequality exacerbate vulnerability to climate change impacts. The IPCC's (2019, CCB Gender) special report⁸ identifies particular climate vulnerabilities experienced by rural women, noting that in "agricultural settings of Australia and Canada, for example, climate adaptation can increase women's work on- and off-farm, but without increasing recognition for women's undervalued contributions."
- 12. I have conducted empirical research on gender and climate hazards in rural Saskatchewan for 11 years. The findings of my peer-reviewed research, and that of my students and co-investigators, indicate that:
 - a. Flooding, drought, and wildfire hazards affect Saskatchewan people differently depending on social categories of gender, socioeconomic class, rurality, and Indigeneity. Specific impacts are complex and nuanced but, in general, inequality exacerbates vulnerability.

- b. Agricultural producers in Saskatchewan are significantly negatively affected by climate hazards like drought, flooding, and wildfire due to their dependence on the natural environment for their livelihood. Producers' financial vulnerability to climate hazards is exacerbated by structural political-economic factors, including high input costs, price variability on international markets, debt, depopulation, and corporate concentration in the agri-food sector (Fletcher, 2013⁹; Fletcher and Knuttila 2016¹⁰; Fletcher et al., 2021¹¹; Campbell Gale, Fletcher, and Reed, 2023¹²).
- c. Flood and drought hazards pose challenges for caregiving labour, which is disproportionately performed by women (Fletcher, 2013; Mbuli and Fletcher, 2021¹³). For example, severe droughts affected farm women's ability to maintain household hygiene and care for young children—including infants in diapers—without reliable access to water (Fletcher & Knuttila, 2016). Farm women also report performing emotional support labour to stabilize their families and

- communities during times of crisis, which affects their own mental health (Fletcher, 2017¹⁴).
- d. Farm women report being less likely than men to participate in daily farm decisions, including those relevant to climate adaptation. As such, women may have less control over the climate-related decisions that affect their lives, yet they must deal with the consequences (Fletcher, 2013; Fletcher, 2017).
- e. Low-income people often lack financial resources to cope with, and recover from, a flood or wildfire disaster. For example, in the 2010 Maple Creek flood in southwest Saskatchewan, mobile homes inhabited by low-income people were highly susceptible and many washed away in the flood waters. During the 2015 wildfires in northern Saskatchewan, residents with money and vehicles were more easily able to evacuate than those without. In this way, socioeconomic status significantly shapes vulnerability to climate hazards (Culham, 2020¹⁵; Walker, Reed, and Fletcher, 2021¹⁶).
- f. Research participants report negative mental health impacts from climate hazards. My research suggests that farm men experience negative mental health impacts due to their disproportionate responsibility for farm survival and frequent positioning as "main farmers" (Fletcher, 2013; Mbuli & Fletcher, 2021). Women experience stress related to extension of their labour capacity and deepening of caregiving responsibilities. In northern Saskatchewan, participants who experienced wildfire reported the ongoing mental health impacts of evacuation (Walker, Reed, and Fletcher, 2021). The wellbeing of Indigenous residents was

- negatively affected by the loss of traditional places and practices like berrypicking and the collection of medicines (Walker, Reed, and Fletcher, 2021).
- g. Climate hazards may worsen the ongoing consequences of colonization and structural racism. In a study of northern Saskatchewan, wildfire hazards worsened socioeconomic inequalities for Indigenous people (Walker, Reed, and Fletcher, 2021). Participants reported that their Indigenous and local knowledge was not recognized as valuable, and that evacuation processes reproduced historical trauma. For example, evacuation centres were compared to residential schools by a survivor, and Indigenous women expressed fear of having their children apprehended while staying in the evacuation centre (Walker, Reed, and Fletcher, 2021). In addition, Elders reportedly became ill due lack of access to traditional foods (Walker, Reed, and Fletcher, 2021).
- h. For an Indigenous community affected by flooding, historical underfunding for housing left participants living in unsafe conditions—such as homes with black mold—for years (Fletcher & Antonini, 2021¹⁷).

13. The previous points are presented as evidence that climate change is driven primarily by GHGs, of which the oil and gas sector is a primary emitter. Climate change has damaging impacts in the form of climate hazards (e.g., flooding, drought, and wildfire), which disproportionately impact agricultural producers, women, low-income people, and Indigenous communities.
